An Act to apply a sum from the Consolidated Fund for additional expenditure for the service of the year 1989 and to appropriate that sum for certain purposes.

BE IT ENACTED by the Duli Yang Maha Mulia Sen Paduka Baginda Yang di-Pertuan Agong with the advice and consent of the Dewan Negara and Dewan Rakyat in Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the Supplementary Supply (1989) Act 1990. Short title.

2. (1) The issue is authorised of a sum not exceeding two hundred and forty six million three hundred and fifteen thousand six hundred and seventy nine ringgit (\$246,315,679) from the Consolidated Fund for expenditure on the services specified in the Schedule for the service of the year 1989, not provided for or not fully provided for by the Supply Act 1989, the Supplementary Supply (1988 and 1989) Act 1989 and the Supplementary Supply (1988 and 1989) Act 1990. Further expenditure for the year 1989. Act A713. Act A736. Act A745.

(2) The said sum is appropriated for the purposes specified in the Schedule.
