An Act to apply a sum from the Consolidated Fund for additional expenditure for the service of the years 1989 and 1990 and to appropriate that sum for certain purposes for the years aforementioned.

BE IT ENACTED by the Duli Yang Maha Mulia Seri Paduka Baginda Yang di-Pertuan Agong with the advice and consent of the Dewan Negara and Dewan Rakyat in Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the Supplementary Supply (1989 and 1990) Act 1990. Short title.
  
2. (1) The issue is authorised of a sum not exceeding one thousand two hundred and fifty-two million four hundred and seventy-eight thousand and seven hundred ringgit (\$1,252,478,700) from the Consolidated Fund for expenditure on the services specified in the First Schedule for the service of the year 1989, not provided or not fully provided for by the Supply Act 1989, the Supplementary Supply (1988 and 1989) Act 1989, the Supplementary Supply (1988 and 1989) Act 1990 and the Supplementary Supply (1989) Act 1990. Further expenditure for the year 1989.

- (2) The said sum is appropriated for the purposes specified in the First Schedule.
  
3. (1) The issue is authorised of a sum not exceeding one hundred and twenty-two million two hundred and forty-three thousand and four hundred ringgit (\$122,243,400) from the Consolidated Fund for expenditure on the services specified in the Second Schedule for the service of the year 1990, not provided for or not fully provided for by the Supply Act 1990. Further expenditure for the year 1990,

(2) The said sum is appropriated for the purposes specified in the Second Schedule.
