An Act to apply a sum out of the Consolidated Fund for the service of the year 1991 and to appropriate that sum and such other sums as have been authorised as expenditure for the service of part of that year.

BE IT ENACTED by the Duli Yang Maha Mulia Seri Paduka Baginda Yang di-Pertuan Agong with the advice and consent of the Dewan Negara and Dewan Rakyat in Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the Supply Act 1991. Short title.

2. (1) The issue of a sum not exceeding twelve thousand eight hundred and six million seven hundred and five thousand four hundred and ninety ringgit (\$12,806,705,490) out of the Consolidated Fund for the service of the year 1991 is hereby authorised. Issue and appropriation for service of the year 1991.

- (2) The sum authorised to be issued by this Act and the sum of six thousand and three million four hundred and thirty six thousand and twenty ringgit (\$6,003,436,020), being the amount of expenditure authorised by section 2 of the Consolidated Fund (Expenditure on Account) Act 1990, amounting in the aggregate to eighteen thousand eight hundred and ten million one hundred and forty one thousand five hundred and ten ringgit (\$18,810,141,510) are hereby appropriated and shall be deemed to have been appropriated as from the date of coming into force of the Consolidated Fund (Expenditure on Account) Act 1990 for the purposes specified in the Schedule.
