An Act to apply a sum from the Consolidated Fund for additional expenditure for the service of the years 1990 and 1991 and to appropriate that sum for certain purposes for the years aforementioned.

BE IT ENACTED by the Duli Yang Maha Mulia Seri Paduka Baginda Yang di-Pertuan Agong with the advice and consent of the Dewan Negara and Dewan Rakyat in Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the Supplementary Supply (1990 and 1991) (No. 2) Act 1991. Short title.

2. (1) The issue is authorised of a sum not exceeding five million two hundred and twenty seven thousand and three hundred ringgit (\$5,227,300) from the Consolidated Fund for expenditure on the services specified in the First Schedule for the service of the year 1990, not provided for or not fully provided for by the Supply Act 1990, the Supplementary Supply (1989 and 1990) Act 1990 the Supplementary Supply (1989 and 1990) (No. 2) Act 1990 and the Supplementary Supply (1990 and 1991) Act 1991. Further expenditure for the year 1990.

(2) The said sum is appropriated for the purposes specified in the First Schedule.

3. (1) The issue is authorised of a sum not exceeding four hundred and ninety one million five hundred thirty seven thousand and six hundred ringgit (\$491,537,600) from the Consolidated Fund for expenditure on the services specified in the Second Schedule for the service of the year 1991, not provided for or not fully provided for by the Supply Act 1991 and the Supplementary Supply (1990 and 1991) Act 1991. Further expenditure for the year 1991.
