An Act to apply a sum from the Consolidated Fund for the service of the year 1992 and to appropriate that sum for the service of that year.

BE IT ENACTED by the Duli Yang Maha Mulia Seri Paduka Baginda Yang di-Pertuan Agong with the advice and consent of the Dewan Negara and Dewan Rakyat in Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the Supply Act 1992. **Short title.**

2. The issue of a sum not exceeding twenty three billion one hundred and fifty one million eight hundred and fifty two thousand and eight hundred and ninety ringgit (\$23,151,852,890) from the Consolidated Fund for the service of the year 1992 is hereby authorised, and the said sum is appropriated for the purposes specified in the Schedule. **Issue and appropriation for service of the year 1992.**
