- i. kerana secara langsung menyebabkan ibu, bapa atau penjaga (yang bukan Islam) dan memilih untuk memeluk Islam akan kehilangan hak penjagaan anak tersebut; sekaligus membantutkan usaha da’wah Islam kerana bukan Islam akan menjadi ragu-ragu untuk memeluk Islam kerana khuatir kehilangan anak;
- ii. dalam keadaan kedua ibu-bapa kanak-kanak (yang asalnya bukan Islam) memilih untuk memeluk Islam maka dasar “common religion” tersebut akan menyebabkan kanak-kanak itu kekal dalam agama asal ibubapanya dan oleh itu mendedahkan kanak-kanak itu menjadi perebutan untuk penjagaan oleh mana-mana pihak ketiga yang bukan Islam;

- iii. sedangkan hukum syara' menetapkan bahawa dalam keadaan mana-mana salah seorang ibu-bapanya memeluk Islam maka kanak-kanak dibawah umur aqil baligh itu hendaklah dianggap Islam.
- iv. Dalam kes *Nedunchelian v. Nur Safiqah* [2005] 2 AMR 711, Mahkamah Tinggi sivil telah memutuskan bahawa menurut hokum syara' berdasarkan fahaman mazhab syafi'e (yang dianuti majority umat Islam di Malaysia) bahawa apabila salah seorang ibu atau bapa seseorang kanak-kanak itu memeluk agama Islam, maka secara automatik anak-anak itu juga dianggap Islam, tanpa perlu kepada formaliti atau persijilan pemelukan kepada agama Islam.
- v. Mahkamah Rayuan didalam kes *Subashini* [2007] 2 AMR 540 telah memutuskan bahawa isu ini tertakluk kepada Artikel 12 (4) Perlembagaan Persekutuan yang memperuntukkan bahawa "ugama bagi seseorang yang berumur kurang daripada 18 tahun adalah ditetapkan oleh ibu bapa atau penjaganya" dan Mahkamah Rayuan menafsirkan bahawa hak menentukan agama seseorang kanak-kanak bergantung kepada mana-mana salah seorang daripada mereka iaitu ibu, bapa atau penjaga. Bermakna salah seorang daripada mereka berhak untuk menentukan agama yang boleh di anuti oleh anak-anak mereka.
- vi. Keputusan Mahkamah Rayuan ini bersesuaian dengan keputusan Mahkamah Persekutuan didalam kes *Teoh Eng Huat v. MAIK* [1990] MLJ 300.
- vii. Bahawa dasar "common religion" ini hanya berteraskan kepada anggapan bahawa kanak-kanak itu dianggap menganut agama ibu-bapanya semasa dilahirkan, dan tanggapan itu termansuh dengan sendirinya apabila kanak-kanak itu mencapai umur 18 tahun dimana diwaktu itu sebagai seseorang yang sudah cukup umur kanak-kanak itu mempunyai hak untuk menentukan agama pilihannya. Sudah tentu dasar seperti ini bercanggah dengan hukum syara' kerana seseorang kanak-kanak Muslim itu dianggap kekal Muslim apabila mencapai umur aqil baligh melainkan diisytihar murtad oleh mana-mana Hakim syarie yang melaksanakan undang-undang Islam.
- viii. Dasar ini juga akan menyebabkan pasangan yang memeluk Islam itu terikat kepada sistem perundangan yang bukan Islam dan ini bercanggah sama sekali dengan hukun syara dan juga Artikel 11 Perlembagaan Persekutuan yang menjamin dan kebebasan mana-mana warganegara menganut dan mengamal agama pilihannya, bermakna apabila beliau memilih Islam maka beliau berhak untuk dibicarakan di Mahkamah Syariah menurut undang-undang munakahat Islam;

- ix. Dasar yang diputuskan oleh kabinet termasuk mengarahkan kes-kes seumpama diatas dibicarakan di Mahkamah Sivil dan melaksanakan dasar “common religion” akan menyebabkan kepada percanggahan dengan hukun syara, bercanggah dengan Artikel 11, Artikel 12, Artikel 121 (1A) Perlembagaan Persekutuan dan bercanggah denan keputusan-keputusan yang dibuat oleh Mahkamah Persekutuan dan lain-lain.
