ORDERS OF THE DAY AND NOTICES OF MOTIONS

1. Resumption of consideration of the Development Estimates 1961 (Cmd. 18 of 1961) in Committee of the whole House (25th April, 1961).

2. The Minister of Internal Security to move:

That the First Report of the Committee of Privileges (Second Session) which has been presented to the House as Paper No.D.R.2 of 1961, be adopted.

3. Enche V. David to move:

That this House hereby resolves that in view of the repeal of the Emergency Regulations on 31st July, 1960, it is desirable that the Trade Union Ordinance of 1959 should be revised and modified to permit the ratification of I.L.O. Convention No.87 of Association of the protection of the Right to Organise, 1948.

4. Dato' Mohammad Hanifah bin Haji Abdul Ghani to move:

That legislation be introduced to prohibit the employment of non-Federal Citizens in Government Departments and in commercial and industrial firms in the Federation, provided, however, that skilled workers who are not Federal Citizens may be employed for a limited period.

5. Enche Tan Phock Kin to move:

In view of the fact that the entry of industrial and agricultural products from Penang to the Federation is being crippled by the imposition of customs duties, this House is of the view that the Honourable the Minister of Finance should review the whole structure of customs duties so that products of Penang origin can find a market in the Federation and compete with similar products produced in the Federation on a free and equal basis.

6. Che Khadijah binti Mohd. Sidek to move:

That this House resolves that the national flower of the Federation of Malaya shall be changed to "Anggerak Kinta".

7. Enche K. Karam Singh to move:

That this House views with concern the adverse effects on the medical services of the present system of hospital charges and specialists' fees and resolves that a commission of inquiry be appointed to review the said system of hospital charges and specialists' fees with a view to ensuring that the best medical treatment and medical skill are extended to all patients, irrespective of their economic standing, in Government hospitals throughout the Federation.

8. Enche V. David to move:

That this House views with great concern the use of the Internal Security Act, 1960, by the Government to arrest and detain twelve Socialist Front Leaders and two trade union workers.

9. Enche V. David to move:

That this House reaffirms its support of the stand taken by the Prime Minister on trade boycott of South African goods and considers that the Federation Government should sponsor a resolution at the United Nations calling for a world-wide boycott of South African goods.

10. Enche V. David to move:

That this House considers that the Government should inform the Secretary-General of the United Nations that this House is of the opinion that the continued presence of Malayan troops in the Congo will depend on:

- (a) the withdrawal of all Belgian military and administrative personnel;
 - (b) the early re-convening of the Congolese Parliament; and
 - (c) the bringing to justice of the murderers of Mr. Patrice Lumumba.
