QUESTIONS FOR ORAL ANSWERS

- \*1. Tengku Zaid bin Tengku Ahmad: To ask the Minister of Commerce and Industry for the full list of the Executive Staff of the F.I.D.A. and to give the qualifications, age, experience, citizenship status and remunerations.
- \*2. Tengku Zaid bin Tengku Ahmad: To ask the Minister of Commerce and Industry for the full list of the non-Executive Staff of the F.I.D.A. according to racial breakdown.
- \*3. Tengku Zaid bin Tengku Ahmad: To ask the Minister of Commerce and Industry for the full list of the Executive Staff of the M.I.D.F.L., and to give the qualifications, age, experience, citizenship status and remunerations.
- \*4. Tuan Ahmad bin Arshad: To ask the Minister for Local Government and Housing to state:
- (a) the finding of the Commission of Inquiry into the City Councils, Municipality Councils, Town Councils and Local Councils and when a White Paper on this inquiry will be issued;
  - (b) whether it is a fact that the election of the said Councils will be held this year; and
  - (c) the number of such Councils that have been taken over by the State Governments and the reasons for this move.
- \*5. Tuan Ahmad bin Arshad: To ask the Minister for Local Government and Housing:
- (a) whether the Ministry helps in administering housing schemes under the F.L.D.A., and if not, why; and
  - (b) whether the Ministry has held any consultation with the Ministry of National and Rural Development about this matter so far.
