Parliament Select Committee on IPCMC 2019 by Joshua Y C Kong 8/11/2019

1. I hope the Bill on IPCMC 2019 so long delayed since 2004 after the RCI report on Police or PDRM affairs was published in 2005 would deal with this issue which is about lodging Police Reports and get proper responses especially if Penal code 202 is to be applied when Police, MACC, Suhakam and BPA had not dealt with the concrete information supplied by me in more than 30 bulky Police Report and a copy of up to 26 reports is attached.

Briefly my experience with the Police in dealing with lodging Police Reports since 1980 after returned from London. I wished I never need to lodge Police Reports but unusual circumstances demand that I had to go that way.

1980-1985 very fearful to lodge Police reports hearing from people and such fear is confirmed in lodging Police reports on MPKK (now DBKK) on parking tickets; then 1986 for lodging Police Reports on N16 Api-Api 1986, then on milk case in 1987; the reason was Police was bias and pro-authorities and very difficult to lodge Police reports and fear tainted on both sides; Then after RCI on police conduct and management 2004, it was disclosed that we can lodge Police without fear or favour and so I lodged more than 30 Police Reports from 2004 to 2019 but I believe the Police did not act accordingly on them, and so the question is what is the difference if any? So is the PDRM subject to PC 202 for failure to act on my Police reports full of documentary evidence? Likewise, are MACC , Suhakam and Biro Pengaduan Awam (BPA) as reports lodged as extended to them subject to PC 202?

2. I have not been to the KK down town Police station since 1988/1989, is the toilet now clean? Are all toilets in all Police Stations now clean? There is much improvement with the Karamunsing Police station for the public and staff alike.

under Penal code 202 which states that in Act 574 -202 of the Penal code as "Whoever, knowing or having reason to believe that an offence has been committed, **intentionally** omits to give any information respecting that offence which he is legally bound to give, shall be punished with imprisonment for a term which may extend to six months or with fine or with both."
