On 23/03/2018 BETWEEN 19.30 - 20.00 HRS I WAS INSIDE MY HOUSE AT NO 235 LORONG 4F2 JLN KERANJI TABUAN DESA KUCHING. MY NEIGHBOR STAYING AT 236 TABUAN DESA, BANGED ON A SIDE SPANDEX PARTITION. THE NOISE CAUSED ME TO GO OUT AND CHECKED. MY NEIGHBOUR, MR. KHO SCOLDED ME "SEE, SEE WHAT?" I WHEN I ASKED HIM WHY DID HE "BANGED" THE SPANDEX-PARTITION, HE SCOLDED ME "LANCHAU" (IN HOKKIEN WHICH IS A BAD WORDS) AND EVEN HURLED INSULTS AT MY MOTHER "YOUR MOTHER'S CUNT", AND OHER PROFANITIES. I SCOLDED HIM YOU ARE A COMPULSIVE FAULTFINDER! Mr. KHO'S WIFE THEN CAME OUT, SCOLDING ME. WE QUARRELED AND MR. KHO LUNGED AT ME ATTACKING ME WITH A CURVE KNIFE AND ASSAULTED ME HE THEN PRETENDEED TO BE LIKE A VICTIM WHERE HE RUN TO THE OTHER SIDE. I ASKED HIM WHAT DID HE USED TO ATTACKED ME? I WAS THE VICTIM OF ASSAULT WHEN THE WIFE OF MR KHO EVEN CALLED THE POLICE (TABUAN JAYA) BECAUSE THEY ARE AFRAID THAT IF I WAS THE ONE INJURED THEY MAY BE IN DEEP TROUBLE. I DID NOT ASSAULT MR. KHO OR ANYONE BY WILLFUL INTENT, AND I AT NO MATERIAL TIME POSSESED ANY KIND OF WEAPONS THAT CAN INJURE ANYONE. I WAS BLEEDING PROFUSELY FROM THE INJURY OF MY LEG. MY MOTHER MY AUNTIE AND MY UNCLE ASSISTED ME AT THE HOSPITAL AND THE POLICE STATION.



RE : SUBMISSION OF CCTV RECORDINGS IN A PENDRIVE AS EVIDENCE FOR POLICE ACTIONS TO BE TAKEN

I humbly request your good self, Tuan Datuk SAC Dev Kumar to kindly observe the CCTV evidence on the above caption-subject matter wherein I was assaulted by my neighbour, Mr. Kho Yhung Seng, aided and assisted by his family members, using possibly from a 'sharp-curve-knife' to wooden sticks that resulted injuries to multiple parts of my body – my left leg needed 3 stitches to have the bleeding stopped.

Mr. Kho's wife, Mdm. Mao, even telephoned the police, and what I have heard what she told the police patrol-officers, *she concocted lies that I was using a knife to attack her husband – the husband managed to dodge the knife attack that resulted me slashing myself on my leg* and the police officers were seen on CCTVs playbacks that they were searching the compound inside and outside of my house and nearby areas for a **'FICTITIOUS'** weapon. Even when I was at the police station, the I.O. even inspected my sling-bag when Mr. Kho told the I.O. that I hid the knife inside my sling-bag. All these searches **FAILED** simply because - *the real sharp weapon used to assault me that resulted my leg having 3 stitches has been hidden by my assailant, and having concocted lies and falsehoods to protect himself and his family from criminal actions.*

On CCTV 3, between on or about 19.32-19.35p.m. on 23.03.2018, Mr. Kho's wife, picked-up a false argument with me after I went outside of the gate area after a sounds of someone hitting the constructed spandex-side partition. I was assaulted by possibly a 'sharp-curve- blade' and pummelled by Mr. Kho between about 19.33-19.33.20. On or about 19.36.50, he was seen to have weapons hid under the rear of their car. On about 19.38.35, one of his family member handed him a stick used to assault me.

On CCTV 1 recordings, he was using stick/s to assault me [also shown in CCTV 3 wherein he was using sticks chasing after me], and he even refused to allow me to go back home having even pleaded with him to have compassion that my leg was bleeding profusely and I needed treatment. He was all the way assaulting me with sticks and refusing me by blocking me from going home and to seek medical attention. My mobile phone was not with me at that material time.

I humbly place on records that based on CCTV 4 recording, on or about 20.46- 20.53.09 the same evening, a group of people arrived at/near my house area. One of the men, shouted at me while I was inside the ambulance. The same person between about 20.52 to 20.53 entered my house-gate and a police officer is seen to have advised him to leave. At the hospital, the same man and one of his friend, even 'browbeat' us [my uncle, my mother and my aunty] having pretended to be escorts of Mr. Kho, when the latter was seen at the hospital seeking treatment. One of their men even scolded my mother '*pukimak*' sparking a pandemonium - resulting reinforcement of security personnels of the SGH and even police officers were called-in. I have repeatedly from my house to the police station at Simpang Tiga urged the police to take appropriate actions against 'the escorts' of Mr. Kho.

I humbly await your kind and appropriate actions as I await this case to be investigated by the police and I humbly appeal to your good self, Tuan SAC, to monitor the case and have justice serve accordingly.





PENGADU TAIP SENDIRI REPOT DALAM BAHASA INGGERIS SEPERTI BERIKUT : -

BASED ON POLICE REPORT NO REPORT : TABUAN JAYA/00137/18 THE CASE WAS INVESTIGATED BY INVESTIGATING OFFICER, INSPECTOR MUZAFFAR SHAH. ALTHOUGH THE CASE HAS JUDGEMENT DELIVERED BY THE MAGISTRATE COURT ON 15.05.2018. THE NIGHT OF THE INCIDENT. THERE WERE TWO GANGSTERS THREATENING ME - AT MY HOME, AT THE SARAWAK GENERAL HOSPITAL, AND THEY ALSO APPEAR AT ONE STOP CENTRE SIMPANG TIGA ALTHOUGH THEY DID NOT MAKE ANY THREATS AT SIMPANG TIGA POLICE STATION.

ONE OF THE GANGSTERS THREATENED ME TO -BE CAREFUL-. -i WILL FIND YOU" IN HOKKIEN LANGUAGE WHEN I WAS INSIDE THE AMBULANCE AT MY HOME AMONG OTHER THREATS. AT THE SARAWAK GENERAL HOSPITAL, THESE GABNGTERS CAUSED A PANDEMONIUM, RESULTING THE HOSPITAL TO CALL IN INTERNAL SECURITY AND THE POLICE.

WHEN I WANTED TO LODGE A POLICE REPORT OR INCLUDE IT IN MY POLICE REPORT, THE I.O. REFUSED ME TO MAKE REPORTS AGAINST THIS 2 GANGSTERS. ALSO, AT THE TIME MY CAUTION STATEMENTS WAS THE TAKEN, THE SAME POLICE I.O. REFUSED TO TAKE DOWN THE THREATS BY THIS 2 GANGSTERS.

THIS I.O. MUST NOT BE INVESTIGATING THIS CASE OR HAVE A HAND ON THIS CASE ANYMORE. I LEAVE IT TO THE POLICE TO INVESTIGATE - IMPARTIALLY. SAYA DILAHIRKAN PADA 01.03.1973 DI HOSPITAL UMUM KUCHING, SAYA BELUM BERKAHWIN. SAYA MEMPUNYAI 4 ORANG ADIK BERADIK DAN SAYA MERUPAKAN ANAK SULONG.

S: Adakah kamu ingin bertanyakan apa-apa soalan berkaitan dengan amaran yang diberikan di atas sekiranya kamu bercakap bohong ?

J: Tiada

S: Adakah kamu ada menerima apa-apa dorongan, ugutan, janji atau tekanan untuk memberikan percakapan kepada saya ?

J: Tidak ada.

S: Adakah kamu betul-betul mahu memberikan percakapan kepada saya dan adakah kamu memberi percakapan secara sukarela ?

J: Ya, saya memberi percakapan secara sukarela.

S: Adakah kamu dalam keadaan sihat hari ini ?

J: Ya, kaki saya masih sakit kesan daripada tekanan kes yang lepas.

S: Adakah kamu tahu mengapa kamu dipanggil untuk memberi keterangan hari ini ?

J: Sjn. Normala bt Hasbi yang telah hubungi dan maklumkan kepada saya.

S: Cuba kamu ceritakan apakah perkara yang telah berlaku pada 23.03.2018 jam lebih kurang 1930-2000 hrs?

J: I place on records that I have advice Sergeant Normala who was investigating and recorded this me to add me at my Facebook page because the CCTV footages of my neighbor attacking me can clearly be seen.

Also, my letter to Datuk Dev Kumar, the then CID Head of Sarawak dated 9th April 2019. Please check with Datuk Dev2 pendrive which the relevent attacked on CCTV were uploaded to the pendrive- to the Investigating Officer (I.O), Inspector Muzzafar Shah and Datuk Dev Kumar.

1. In the evening of 23.03.2018, my ex-neighbor – Mr. Kho Yhung Seng and his wife orchestrated a premeditated brutal assault on me. I was snared out of my house, the husband repeated attacked me, and later, the wife of Mr. Kho even make a false distress call to the police patrolmen falsely telling the patrolmen that I assaulted her husband using sharp weapon – i missed- and as a result- I stabbed myself. The police patrolmen believed her wife's story – resulting them to search the parameter of my car porch, and my living room area- an imaginary weapon –that they conctoted- an of course they could not find it.

2. In fact, the husband was the one who assaulted me including sharp weapon, sticks, bare hands. After repeatedly attacked me, I noticed a brick on the ground belonging to other neighbor{notice that this brick was not carried or possessed by me } and threw it at him. Anybody would have done that, unless you want to die ended being beaten. I begged him to stop and I had to pressed the blood coming out from the injury he inflicted on me. I f you see the CCTV footages, I was repeatedly attacked by Mr. Kho, one of his family members even handed over to Mr. Kho a stick used to attack me.

*Nobody would believe by any standard of common sense – if I used a knife to attack his husband according to his wife's version- the husband avert my knife attack – resulting me to stab myself. A more logical version is more persuasive if the wife concocted a story saying, I attacked his husband using sharp weapon – he gradded that weapon use to assault him- as he took hold of my hand – and stabbed myself.

3. Many of there friends and relatives arrived at my house compound – among others 2 samsengs threated me from my house and to the hospital – At the hospital, even the security of the hospital and the police has to be called in to avoid the pandemonium caused by the 2 samsengs by Kho Yung Seng.

At One Stop Centre, early morning of 24.03.2018, I have repeatedly asked Inspector Muzzafar Shah to take actions against:-

1. The wife of Mr. Kho Yhung Seng who made a false distress call – that I was the attacker.

2. Mr. Kho Yhung Seng who was the attacker, and if he sustained injury, I did it out of self-defence. Please see clarification above!

3. To take actions against the 2 samsengs

All these very fair and my fundamental right to policing were taken away by Inspector Muzzafar Shah. He repeatedly refused all these request – if face – he threatened to lock me and Mr. Kho Yhung Seng in a same lock up if I refused to settle. Of course, Mr. Kho wanted to settle. To settle means that it – the Inspector has ,protected him from prosecution. Why the Inspector resued to investigated.

S: semasa kejadian adakah jiran kamu (Mr Kho Yhung Seng) mengeluarkan kata-kata ugutan terhadap kamu?

J: At first, I remeber he banged the spandex – dividing our house. Then the wife picked up a false quarrel with me – so that the husband could attack me. If you look at the sizr of the husband – he was far taller and bigger than not to mention he was armed. IT was premediatated!

S: Sekiranya ada boleh kamu beritahu saya apakah ugutan yang telah dikeluarkan oleh Mr Kho?.

J: He repeatedly hurled insult in Hokkien ,Your mother's cunt among others

S: Semasa pengelutan kamu dengan Mr Kho adakah dia mengeluarkan apa-apa senjata dan apakah jenis senjata tersebut?

J: Knife that looks like a spur, sticks, and he also attacked me with bare hands as can be seen by the CCTV.

S: Sekiranya kamu mengalami kecederaan semasa pergaduhan dengan Mr Khoo adakah kamu pergi mendapatkan rawatan di Hospital dan berapa lama kah kamu di tahan di wad?

J: Mentioned above, I did, I was the one who called the ambulance when the prolmen police refused to call.

S: Adakah kamu ingat bila kes kamu disebut di Mahkamah?

J: 15 th May 2018

S: Setelah perbicaraan selesai apakah keputusan kes yang telah dibuat oleh pihak Mahkamah?

J: Section 67 of the CPC. Inspector Muzzafar Shah telephoned me the late evening of 14th May 2018 telling me to be present as the Magistrate Court as I will be charged under Section 67 of the CPC. He told me that it is not finable andailable (sangat ringan). AT that time I repeatedly goes to the klinik to seek medical treatment for my leg. As I was using a ,tongkat' as a walking aid, at the court area, Mr. Kho even laughed and smirked at me. This process of law was used to cover Mr. Kho from the crime that he committed.

S: Seperti yang kamu telah sedia maklum keputusan Mahkamah telah selesai dan hukuman telah dijatuhkan. Apakah menyebabkan kamu tidak berpuas hati terhadap Insp. Muzaffar?

J: Because as mentioned above – when the caution statement was taken sometime on 12/04/2018 probably after my Letter to Datuk dev Kumar – Most contents in the caution statement was dictated by the I.O. For example, I AGAIN urged his to take actions against Mr. Kho's wife for making a false duress call, Mr. Kho who assaulted me, and also to arrest the 2 samsengs – he refused – as of the case of the 2 samsengs – he cited it as IRRELEVANT!

When I lodged a police report against Inspector Muzaffar Shah on 24.01.2019 – the lady policewoman, Khatizah bt Hassan alerted Inspector Muzaffar Shah – and he came to the police station and wanted to take down my caution statement – I refused as I told him that you are the culprit – how could you be blatant enough to take my Caution Statement – finally Inspector Ting arrived later to take my Caution Statement.

ADDENDUMS : The reason I lodged this complaint and prior police report are to :

Justice must persevere and some of the police cannot keep on abusing their powers like that continuously.

To have this case re-opened so that the culprits can be prosecuted in a fair trial including the 2 samsengs who threatened me.

-Kindly also check the police report including the caution statement taken by Inspector Ting on 24.01.2019 (TABUAN JAYA000369/19)

- The contents of my Letter to Datuk Dev Kumar, complaint against the said Inspector dated 9th April 2018

-My letter to the Inspector general of police dated 13.06.2019

I personally and prayfully that the police will not keep covering their colleagues for lawful actions.

My trauma injury leg inflicted by Mr. Kho – I am still seeking treatment from hospitals and the cost has been high and possibly – an operation is required – even though it does not guarantee of recovery.

Among other matters.


I humbly congratulate your appointment as the new KPD recently and your stern actions against errant police officers.

The above caption subject matter wherein I was assaulted by my neighbour – aided by their family members– in the evening of 23.03.2018 – in a pre-meditated sharp weapon, ‘rattan’, and fists attack by my ex-neighbor, Mr. Kho Yhung Seng as mentioned in **POLICE REPORT NO : TABUAN JAYA/001374/18**.

Having being assaulted with various weapons, the wife of the assailant, made a **FALSE EMERGENCY CALL to the police FALSELY ALLEDGING that I was the one which attempted to assault the husband or my attacker**, which the police patrolmen **BELIEVED in THE CONCOCTED STORY** resulting the police patrolmen to search my house compound for an imaginary weapon that never existed. At that material time I was severely bleeding at my left knee area which rendered me in pain and limited mobility.

Two ‘samsengs’ then arrived to my house compound threatening me when I was inside the ambulance. They were also called in by my attacker at the hospital and threatening me resulting the hospital security and police to be called in to prevent further pandemonium.

After outpatient treatment at the **Sarawak General Hospital (SGH)** on 23 and 24.03.2018 I was assisted by my relatives to **ONE STOP CENTRE, SIMPANG TIGA** to lodge a police report against my attackers and their 2 ‘samsengs’. Instead the Investigating Officer (I.O.) repeatedly wanted me and my attacker to settle the matter. My attackers and his families and the 2 samsengs were even



present at the police station which I believed has concocted lies and falsehoods about the whole event.

I refused repeatedly to settle the matter as I was the aggrieved party, but after being threatened by the said I.O. to lock us both up at the same cell and charged us the next day – the aggravating pain in my injured knee and the need to take the prescribed painkiller – which the I.O. refused me to access to medication – **FINALLY, after my repeated attempts for him to investigate the case which he refused,** I gave in to this I.O.'s wishes that this case is to be settled. I also overheard this I.O. talking to a supposedly his superior officer over his mobile phone to have this case settled. **This I.O., Inspector Muzzafar Shah also refused my request to report the 2 'samsengs'.** To summarised it, the police report made on 23.03.2018 was directed by the I.O. to favour my assailant and his family from criminal actions.

I decided to write to the then **SAC Datuk De. Kumar, Ketua jabatan Siatan Jenayah, Sarawak** to call for appropriate actions to be taken, having submitted the letter and CCTV recordings of the assault in a pendrive and to re-investigate the case, having someone drove me to his office and submit the said materials to his secretary without meeting him on 9th day of April 2019.

The result of my letter to **SAC** on 9th April 2018 resulted myself being telephoned by the said I.O. one day earlier to be present in the morning of 12.04.2018 to have my **CAUTION STATEMENT** recorded. When taking down my caution statement, the I.O. refused to take down certain important matters on my assailant and also the 2 'samsengs'! And the travesty of the case was that – I was issued with an **ARREST SHEET investigated under SECTION 324 of the PENAL CODE** – prior to that the said I.O. told me I won't be locked-up and told me to submit the **PENDRIVE** of the CCTV recordings/footages that my neighbour assaulted me!


I duly submitted the pendrive to him the next day 13.0.2018. I place on records that I have been going frequently to the polyclinics due to the injury of my knee. The injury of my knee has not heal till date as I have frequently visiting the Orthopaedics Department at the SGH, private hospital, physiotherapist, Pain clinics, etc.

On the 14th of April 2018 I was telephoned by the said I.O. to be present at the **MAGISTRATE COURT** the next day to be charged under **SECTION 67 of the PENAL CODE**. The I.O. told me, should I not plead guilty to **this non-finable, non-jailable charges at the Magistrate Court, he would press serious charges against me. I pleaded guilty on 15.04.2018 under SECTION 67of the PC.** I was made to understand that my assainlant, Mr. Kho Yhung Seng was also charged under the same Penal Court the same day although we were present at the separate magistrate court.

I was and still undergo and visit the Hospitals, Polyclinics for treatment as the result of the aforesaid injury on my knee.

On 24.th day of January 2019, I lodged a police report against the said Inspector (I.O.). At the time I was in the middle of lodging **POLICE REPORT NO : TABUAN JAYA/000369/19 , the lady police officer which was taking down my report which I typed myself alerted Inspector Muzaffar Shah – he rushed to the police station and advised me against making this police report. I refused as I was accompanied by representatives of a MP – he then wanted to take down my caution statement.** I refused as I advised him that he was the person-of-interest in this police report. At last, Inspector Ting took down my caution statement. Until now, after at least 1 follow up – the case seems to be no further action against this Inspector which abused his power whenever it pleases him.

With respect to the Royal Malaysia police, this case is a travesty of justice. This Inspector- Muzaffar Shah investigating the case has been abusing his power at my expense.




My CCTV recordings – the footages clearly showed him attacking me with fists, and his family member handed him a stick/cane to beat me.

- I called upon your kind re-investigation of this whole episode against my attacker/and his family members.
- The police must be independent if possible from Bukit Aman so that no more further abuse of power may be used to serve the interest of the corrupt
- The 2 samsengs must be brought to justice for criminal intimidation


