## **PAC MEDIA STATEMENT**

- 1. The Public Accounts Committee (PAC) today tabled the PAC Report on Finance Ministry (MOF) and Agriculture and Food Security Ministry (KPKM)'s follow-up actions on PAC's recommendations regarding the National Paddy and Rice Management Concession Agreement's social obligation payment receipts (DR.7/2023).
- 2. The report is to inform about the follow-up actions taken by the KPKM based on the recommendations made by PAC in the PAC Report DR. 7/2023, which was tabled in the Parliament on 11 October 2023. The Committee elaborated follow-up action the on each as per recommendations given to KPKM.
- 3. On 11 Mar 2024, PAC held proceedings on MOF and KPKM's follow-up actions and the witnesses who were present are as follows:
  - i. Datuk Dr. Shahrazat binti Haji Ahmad, Deputy Secretary General, MOF Treasury (Investment);
  - ii. Datuk Lokman Hakim Ali, Secretary General, KPKM; and
  - Datuk Azman Mahmood, Director General of Paddy and Rice iii. Supervision cum Division Secretary of Paddy and Rice Industry, KPKM.

4. Following that, PAC stressed that KPKM needs to ensure that each social

obligation as agreed between BERNAS and the Government in the

concession agreement signed is fulfilled at all times throughout the

concession period.

5. Besides that, KPKM also needs to ensure that the trust account for social

obligation is well maintained with the distribution and use of the fund be done

according to the terms stipulated in the concession agreement and trust

deed.

6. PAC also requested that the development of the SMART paddy sistem be

accelerated and launched ealier than initially planned by KPKM and

BERNAS to ensure the integrity of the farmers' data so that issuance of

subsidy payment under the Paddy Price Subsidy Scheme can be carried out

in a more transparent, efficient and organized manner.

7. PAC was informed that the KPI report for the implementation of the 10 social

obligations has already been developed and prepared twice yearly.

Therefore, PAC wanted the KPI reporting to be increased to four times

yearly, that means to have the report prepared quarterly every year to

ensure that BERNAS really complies with the implementation of the 10

social obligations.
